#### Spring Safety and Enjoyment: A Reminder to Stay Safe

As we welcome the arrival of spring, with its longer days and warmer weather, the anticipation for outdoor activities grows. Daylight Savings Time, starting on March 10th, gifts us with extra daylight hours, encouraging more of us to step outside and bask in the sunshine. Whether it's taking a leisurely walk, cycling through the neighborhood, or simply enjoying the outdoors, the increase in outdoor activities is a hallmark of the season.

However, with the increased foot and bike traffic, the potential for incidents also rises. The Keiser Police Department (Keiser PD) is proactively addressing this by ramping up their presence to ensure that everyone can safely enjoy the beautiful weather. The safety of pedestrians, cyclists, and drivers alike is a top priority, and as such, a friendly reminder is in order regarding the importance of vigilance and adherence to local traffic regulations.

#### Speed Limit Enforcement

The Keiser PD will be strictly enforcing speed limits to protect all members of our community. In residential areas, the speed limit is 15 mph, ensuring the safety of pedestrians and cyclists alike. Main Street will have a speed limit of 30 mph, as will the roads leading out of town. These limits are not only guidelines but will be strictly enforced to ensure everyone's safety. Compliance with these speed limits is crucial for preventing accidents and ensuring a peaceful coexistence between vehicular and pedestrian traffic.

#### **Loose Dogs Ordinance**

Another issue of concern with the increase in outdoor activity is the presence of loose dogs. While most pets are friendly and well-behaved, the reality of potential injuries from dog incidents cannot be ignored. To address this, the city has enacted ordinance 2023-01, which includes a "one strike and you're out" clause. This ordinance states that "Upon infliction of an unprovoked bite, attack, or aggressive behavior on a human or another animal, said dog will be subject to immediate removal from the city limits." This measure is in place to protect our community and ensure a safe environment for everyone to enjoy the outdoors.

#### A Call to Enjoy Safely

The Keiser PD and the city council urge everyone to make the most of the spring season safely. Look out for one another, whether you're behind the wheel, on foot, or cycling through our beautiful city. Let's respect the speed limits, be mindful of our furry friends, and ensure that the outdoor experiences we cherish are safe and enjoyable for everyone.

As we embrace the warmer weather and the beauty of spring, let's do so with a commitment to safety and consideration for all members of our community. Together, we can ensure a season filled with joy, health, and safety. Enjoy the outdoors to the fullest, but let's do it safely. City Council meeting on the 3rd Monday of each month at 6:00 pm. Home owners and contractors are required to notify city hall before any mechanical excavation can be done.

We have this guy I call "Grant" that works for the City of Keiser. He's a hard worker. He's always thinking of ways to make Keiser a better place in which to live. You probably know him as Rick Creecy. Rick was appointed to finish Mayor Eddie Gardner's term after he retired. He was then elected to his own four -year term. After his appointment, he didn't waste any time. He started in at City Hall. In no time, we had everything cleaned up, organized, and a new floor laid.

Once that was done, he began updating our technology and creating programs that enable the business section of Keiser to run more efficiently. He did the same with the outside departments of running a city.

When he ran out of anything else to do, he started writing and submitting grants. Had he ever written a grant before? NO! Did he know how to write a grant? NO! But, he didn't let that stop him. As I've said before, no one told him he couldn't write 60 zillion grants, SO HE DID.

However, the way I looked at it, let him write his grants. Let him get it out of his system. At least, it will keep him out of my hair. Right! No, wrong again. Since I had previously worked at a newspaper, he thought it would be a good idea for me to proofread his grants (100's of pages) before he submitted them. If I balked at the idea, he reminded me that the mayor can delegate additional duties to the Recorder/Treasurer.

It goes without saying that most grants submitted are denied for one of 3 reasons.


- There is a limit to how many grants are awarded in each category.
- Many grant applications submitted do not meet the criteria.
- Some grants are just not written correctly.

I have heard from other grant writers that you have to present an application that gets the "powers that be" in grant heaven's attention. Apparently "Grant" got their attention. Turns out he is pretty good at writing and submitting grants. He has turned in 38 grant applications. Fifteen of those applications, so far ,have been awarded, garnering the City of Keiser \$1,034,082.00 to date. He's not done yet. He submitted another grant application this week.

At this point, I must repeat something I stated in another newsletter. We are not allowed to spend this grant money on anything but what it was awarded for.

Thanks to "Grant's" unwavering persistence, the City of Keiser got its streets paved, our water tank cleaned and painted, our sewer system updated, a re-imagined new park with a walking track, and a first-class police department with a second full-time police officer and two auxiliary officers.

And, lucky me, I get to take care of all that money.



#### **CHIEF ANDREW GATTIS KEISER POLICE DEPARTMENT**

Hello Keiser, I hope everyone is having a good year so far. I am sure most of you have already seen him around, but I would like to welcome our newest Full-Time officer, Gaylon Payton, to the City of Keiser. Officer Payton will be a great addition to our department. So, when you see him out patrolling stop by and introduce yourself. He is looking forward to serving the community and growing alongside us.

During the month of February Officer Payton and myself, Chief Gattis, attended a CRASE instructor course with Texas A&M. CRASE stands for "Civilian Response to Active Shooter Events". With both of us learning the course material and becoming certified to teach this course this will allow us to teach an Active Shooter course to our community and those around us to better prepare everyone just in case there is ever an incident. We hope that an incident like that will never occur in or around our community, but I would also like to make sure that we are all well prepared and know what to do and how to respond during a situation like that. Those of us here at the police department will make sure we stay vigilant and proactive to do our best to prevent such an incident from occurring because our main priority is to the community and the safety of its members.

The class will be announced later this month, and, in that announcement, there will be a date, time and address of when and where the class will take place. The class will be open to anyone who would like to attend, including those outside of our community. This month is going to be a big month for us here at the police department. During the month of March I will be attending the International Law Enforcement Educators and Trainers Association's annual conference where I will be getting certified in more classes so that I can come back and teach our officers. This means all our officers will become more knowledgeable and better equipped to serve our community and the city of Keiser.

I was also selected to attend the Arkansas Association of Chiefs of Police Executive Development Program, which is a big deal for our department. This program allows us access to learn and implement the best practices, policies, and procedures for the state of Arkansas. This means that our department will be on the way to operating at the highest standards, for a police department, that are recommended by the state. Currently there are only 21 total departments in the entire state that have met and currently operate on that level of standard. My goal is to make the Keiser Police Department number 22 on that list. Once we obtain that standard that will also make us the first and only department in Mississippi County that meets those requirements. So, it will be a big accomplishment for our department and our community.

With the weather warming up I would like to start putting together some ideas and plans for community events. Here's an exciting update on our utility work progress! Our diligent contractors have been hard at work since February, and I'm thrilled to report that we're about 25% through the scheduled repairs and upgrades. Let's take a moment to review the enhancements being made to our water system infrastructure:

• The exterior of the tank is undergoing abrasive blast cleaning and painting, ensuring both protection and longevity.

• A new flap-valve, screen, and splash pad will be installed for the tank overflow pipe to better manage excess water.

• We're upgrading with a new aluminum roof vent on the tank for improved ventilation.

• A new 30-inch diameter manway on the tank will be installed, enhancing access and maintenance capabilities.

We're adding a new water mixer to the tank to ensure

consistent water quality by promoting circulation.

• There will be various miscellaneous repairs on the tank to address any minor issues and ensure optimal performance.

- The treatment building is getting necessary electrical repairs to maintain safety and functionality.
- Both the pipe gallery and the treatment building will benefit from abrasive blast cleaning and painting, protecting them from corrosion.
- We're installing a new roof on the treatment building to safeguard our equipment and facilities from the elements.
- And we'll be performing miscellaneous repairs in the treatment building to keep everything in top shape.

These enhancements are part of our commitment to providing the community with the best possible water services. We'll continue to keep you informed as we hit more milestones. Thank you for your continued support and patience as we work towards these important improvements!

## How Do I Know if I'm Doing the Right Thing?


In general, when you do something with faith that matches your morals, creates the welfare of others, and gives you contentment, peace, and self-pride, it means you are doing the right thing.

Although, this definition may alter from situation to situation because life is uncertain, mysterious, and can't be defined in some lines.


*"Life will always throw you curveballs; it's your job to swing the bat."*

As residents of Keiser, we are no strangers to the unpredictable and sometimes devastating forces of nature. The memory of the tornado that struck our community in 2018 is a stark reminder of the havoc severe weather can wreak in just moments. Simple actions, such as avoiding long showers, running dishwashers or washing machines only when full, and fixing any leaks promptly, can make a significant difference.



#### Important Reminder: All-Terrain Vehicle Road Usage in Keiser

The Keiser Police Department wishes to remind all residents and visitors of an important regulation regarding the use of allterrain vehicles (ATVs) within the city limits and on Arkansas roads. In accordance with AR Code § 27-21-106, it is unlawful to operate any three or four-wheeler ATV, or side-by-side, on public roads within the state of Arkansas, including the streets of Keiser.

This law is in place to ensure the safety of not only the riders of these all-terrain vehicles but also the safety of drivers and pedestrians. All-terrain vehicles are designed and manufactured for off-road use and do not possess the same safety features as road vehicles. Riding ATVs on public roads can increase the risk of accidents and injuries, potentially putting both the ATV riders and other road users in danger.

#### **Enforcement in Keiser**

The Keiser Police Department will be actively enforcing this regulation. Anyone found riding an ATV on the streets of Keiser will be issued a citation. This enforcement effort is not about penalizing our community members but about ensuring every-one's safety. We understand the appeal of ATVs and the fun they can provide, but we must prioritize the well-being of all individuals on our roads.

We urge ATV owners to respect this law and to use their vehicles only in designated areas and private properties where it is legal and safe to do so. There are numerous trails and off-road sites that are designed for ATV use, where you can enjoy these vehicles without posing a risk to yourself or others.

#### A Safety-First Community

The decision to enforce AR Code § 27-21-106 strictly within Keiser is made with the community's best interests at heart. Safety is our paramount concern, and by adhering to this law, we can work together to prevent accidents and injuries on our roads.

We appreciate your cooperation and understanding in this matter. Let's all contribute to making Keiser a safer place for everyone, whether they are walking, driving, or enjoying recreational activities.
