IT'S IN THE BANK By Peggy Sellars City of Keiser Treasurer

In the coming months, I plan to answer questions about the city's finances such as: "Where does our money come from to pay the city's bills?"); "What kind of bills does the city have?", and "What checks and balances are in place to ensure our money is spent wisely?'

I thought a good topic to start with would be "How the financial structure of our city is set up."

The City of Keiser actually has ten bank accounts. Each account serves a different purpose. Our General Fund account can be used for any general expenses of the city.

The city's Water Department has two (2) bank accounts, Revenue and Operations. These accounts can only be used for expenses related to water and sewer.

In relation to our Water Department, we have a Meter Deposit account. The money in this account does not belong to the City. It belongs to the citizens of the City. These deposits are returned to the citizens, minus any outstanding water bills, should the citizen move from the City.

We have a bank account called Debt Reserve. The only way this money will ever be used is if the Water Department's finances become depleted. If that should ever occur, the Debt Reserve would be used to make payments on our well loan and our water line loan with the USDA. So far, this has never happened, and I do not foresee it ever happening.

The City of Keiser has a two- percent city sales tax. One-percent of that tax goes into a bank account called One-Cent Water. The other one-percent goes into an account called One-Cent Sewer

The State of Arkansas requires that we have a separate bank account for our street revenue and expenses.

The State mandates that our volunteer fire department have its own bank account called Act 833 Funds.

In 2022, the City of Keiser received an ARPA Grant. Mayor Creecy and I felt this money should be kept separate from our General Fund, so in 2022 we opened an ARPA bank account.

I hope this gives you a clearer understanding of how our city's finances are set up. Next month, I hope to address the topic "Paying the Bills".

NEAL BROWN DIRECTOR OF PUBLIC WORKS WATER TREATMENT & WASTEWATER OPRERATOR

As the City of Keiser's multifaceted Public Works Director for over six years, I've also served as the water and wastewater operator. I manage all city-owned property and oversee one full-time and four part-time employees. My academic background includes a Bachelor of Science in chemistry and biology from Southeast State University and an associate degree in Real Estate Law. I hold Water Distribution Level 1, Water Treatment Level 2, and Wastewater Level 1 licenses, qualifying me in all aspects of the city's water production.

My commitment to providing Keiser's citizens with clean, healthy water has been recognized by the Arkansas Department of Health. My future goals include pursuing grants to finance water tank maintenance and filtration system upgrades.
